

Dear Gottlieb:

Below is the regular monthly accounting as of December 1, 1959.

Line 2 of the accounting below notes an adjustment of \$21,853.28 for the period April 1, 1959 through November 30, 1959. During this period of 8 months we had been listing a regular monthly allocation of \$45,541.67. On October 19, 1959, however, confirmed over the telephone by Mr. I. Hamlin and Mr. J. Leshin to me on November 10, 1959, we had agreed on an annual budget for the American Zionist Council of \$492,280 plus \$87,000 for the Youth budget. This total of \$579,280 requires a monthly allocation of \$48,273.33. The difference of \$2,731.66 per month, or a total of \$21,853.28 over the 8 months noted above, is the amount now added as noted on line 2 below.
