## VIRGINIA COALFIELD ECONOMIC DEVELOPMENT AUTHORITY BOARD OF DIRECTORS MEETING October 18, 2018

The Virginia Coalfield Economic Development Authority Board of Directors met on Thursday, October 18, 2018 at the VCEDA Office, 527 East Main Street, Lebanon, Virginia.

Board members present were: Maggie Asbury, Rick Axthelm, Jim Baldwin, Esther Bolling, Harry Childress, Becky Coleman, Dana Kilgore, Jay Langston, Mark Leonard, Duane Miller, Larry Mosley, J. P. Richardson, Frank Underwood, and Shelbie Willis.

Board members absent were: Josh Ball and Carroll Branham.

Staff present were: Jonathan Belcher, Executive Director/General Counsel; Jean Jordan, Funds Administrator; Marketta Horton, Economic Development Specialist; Susan Copeland, Marketing Coordinator; and Charlotte Mullins and Cathy St. Clair, Marketing Ambassadors.

Chairman J. P. Richardson called the meeting to order at 3:20 p.m.

Upon motion by Harry Childress and duly seconded by Larry Mosley, and unanimously passed with all members present voting in favor thereof, none voting against the same, none abstaining, and with Josh Ball and Carroll Branham absent, the board approved the minutes of the August 16, 2018 meeting.

# I. Chairman called for the Executive Director's Report, and Jonathan Belcher reported –

- A. Activity since the last board meeting has focused heavily on marketing and business development activities, with an uptick in prospect activity.
- B. Project Key and Project Hospitality have located to the region since my last report, both of which were VCEDA-generated leads (announcements pending).
- C. A major expansion by an existing manufacturer is pending.
- D. VCEDA announced 3 new small businesses in the region since the last board meeting.
- E. Prospect activity, particularly from manufacturing companies, is looking good.
- F. So far this year, we have had 53 prospect visits, 160 inquiries, and have completed 20 marketing events.

- G. In 2018, 7 loans and 25 grants have been closed for over \$14.3 million in new VCEDA funding involving a projected 547 new full and part-time jobs.
- H. The Juice & Her Smoothie Bar Grant Announcement On August 16, VCEDA announced the award of a \$10,000 seed capital matching grant to The Juice & Her Smoothie Bar, a new healthy foods business located in North Tazewell. Three full-time and one part-time jobs are projected.
- I. Governor's Visit to AT&T Wireless On August 17, VCEDA attended Governor Northam's visit to the AT&T Wireless customer service center in Lebanon. AT&T Wireless is looking to fill 170 jobs.
- J. No Holds Barred Sauces Grant Announcement- On August 20, VCEDA announced the award of a \$4,500 seed capital matching grant to No Holds Barred Sauces, LLC of Haysi, Virginia. This new specialty sauce and jam company projects 4 full-time employees.
- K. Conaway Broadband Grant Closing On August 24, VCEDA closed an up to \$112,000 loan to the Buchanan County IDA to assist with the extension of broadband into the Conaway area of Buchanan County. Charter Communications is matching these funds.
- L. Business of Food Conference On August 27, VCEDA helped sponsor and had an exhibit booth at the Business of Food Conference held in Abingdon, to market to agriculture/food products businesses.
- M. Adria Auto & Truck Repair Grant Announcement On August 29, VCEDA announced the award of a \$10,000 seed capital matching fund grant to Adria Auto & Truck Repair in Tazewell County. This new business projects 4 full-time employees.
- N. Ultra Health Grand Opening On September 10, VCEDA participated in the grand opening/ribbon-cutting ceremony for Ultra Health Town Center in Grundy. VCEDA approved a \$271,800 loan for the diabetes treatment center, with 10 full-time jobs projected.
- O. International Manufacturing Technology Show On September 10-13, a VCEDA team attended the International Manufacturing Technology Show in Chicago to market to the manufacturing industry. The team had pre-set appointments as well as cold calls at this show, which had over 2,500 manufacturers in attendance.
- P. EWI Reception On September 17, VCEDA attended a reception held by Columbus, OH-based EWI to mark the start of training of the initial 5 mentees in the cybersecurity mentorship program located by EWI in Buchanan County. VCEDA approved up to a \$509,895 grant for this project.

- Q. Breaks Interstate Park Grant Closing On September 24, VCEDA closed a \$92,000 grant to the Breaks Interstate Park to be used for various improvements including replacement of roofs, renovation of the adventure outpost building, construction of a climbing wall, and purchase of recreational equipment.
- R. Lyric Theater Grant Closing On September 25, VCEDA closed a \$40,000 grant to the Town of St. Paul IDA to help renovate the marquee of the historic Lyric Theater in downtown St. Paul, Virginia.
- S. Raven Theater Grand Opening On September 27, VCEDA participated in the grand opening of the Raven Theater in Tazewell County. VCEDA approved a \$125,000 grant for this project. Five full-time and 7 part-time jobs are projected.
- T. Big Stone Gap Grant Closing On October 10, VCEDA closed up to a \$90,000 grant to the Big Stone Gap Redevelopment and Housing Authority for the renovation of the Mutual Pharmacy building in Big Stone Gap, which will be developed into a restaurant and short-stay lodging. 10 full-time and 30-45 part-time jobs are projected.
- U. National HUBZone Conference On October 11-12, VCEDA lead a team at the National HUBZone Conference in Northern Virginia to promote the region to state and federal contractors and to companies needing locations and employees within a HUBZone. A key part of this is the new SW VA Hublink initiative.
- V. CoreNet Global Summit On October 14-17, VCEDA attended the annual CoreNet Global Summit, held this year in Boston, MA. CoreNet Global is the largest gathering of corporate real estate professionals, with over 2,500 attendees from 32 countries.
- W. Virginia Conference on World Trade On October 17-18, VCEDA attended the 70th annual Virginia Conference on World Trade, held in Richmond. This event included a special invitation only reception at the Governor's mansion, which VCEDA attended.

The VCEDA Chairman is hereby authorized to execute any documentation associated with the foregoing.
- C. Upon motion by Rick Axthelm and duly seconded by Larry Mosley, and unanimously passed with all members present voting in favor thereof, none voting against the same, none abstaining, and with Josh Ball and Carroll Branham absent, the board approved grants from the VCEDA Seed Capital Matching Fund to the following small businesses and in the following amounts, to be used for purposes allowed under the standard form VCEDA Seed Capital Matching Fund Grant Agreement:

- D. Upon motion by Rick Axthelm and duly seconded by Harry Childress, and unanimously passed with all members present voting in favor thereof, none voting against the same, none abstaining, and with Josh Ball and Carroll Branham absent, the board approved a request from VFP, Inc. to extend the maturity date of the \$581,000.00 loan from VCEDA to VFP, Inc. (reference Loan Agreement and Promissory Note dated October 4, 2013) for an additional thirty-six (36) months at the same interest rate of 1.625%, with the remaining principal and interest balance of the loan to be due and payable in thirty-six (36) consecutive monthly installments of \$8,809.24 each beginning October 4, 2018, with all other terms and conditions to remain the same. The VCEDA Chairman is hereby authorized to execute any documentation associated with the foregoing.
- E. Upon motion by Rick Axthelm and duly seconded by Esther Bolling, and unanimously passed with all members present voting in favor thereof, none voting against the same, none abstaining, and with Josh Ball and Carroll Branham absent, the board approved a request from the Industrial Development Authority of Wise County ("IDA") to consent to the IDA's leasing of a portion of the Appalachia America Energy Research Center in Wise, and associated parking, to Carbon Research and Development Co., generally in the form of the Facilities Lease as presented in the board packet for this VCEDA board meeting.
- F. Upon motion by Rick Axthelm and duly seconded by Harry Childress, and unanimously passed with all members present voting in favor thereof, none voting against the same, none abstaining, and with Josh Ball and Carroll Branham absent, the board approved up to a \$1,400,000.00 loan to Pemco Corporation (doing business as AMR PEMCO) to be used to finance the purchase of equipment, machinery, and tools, building renovations, expansions, and improvements, and costs associated with the foregoing including delivery and installation expenses, to assist with an expansion of AMR PEMCO at 1960 Valley Dale Street, Bluefield, Tazewell County, Virginia, subject to the following terms and conditions:

- 1. The loan shall be due and payable in eighty-four (84) consecutive monthly payments of principal and interest, with the first such monthly payment due and payable one (1) month from the date of the promissory note. Monthly payments shall be amortized to be as equal as possible in amount, and re-calculated accordingly as loan proceeds are drawn down from VCEDA.
- 2. The interest rate shall be 2.50%.
- 3. The loan shall be collateralized by a first priority security interest in the equipment, machinery, and tools financed with these VCEDA loan proceeds, and by a deed of trust on the AMR PEMCO facility located at 1960 Valley Dale Street, Bluefield, Virginia, which deed of trust may be subject to the existing deed(s) of trust on this property securing VCEDA.
- 4. This loan shall be funded from the VCEDA Tazewell County Account.
- 5. The requirement of a Phase I environmental assessment report is waived on this project, since VCEDA already has Phase I and Phase II reports on file.
- 6. The requirement of a lender's title insurance policy is waived on this project, and an attorney's real estate title search opinion may be submitted in lieu thereof.
- 7. The VCEDA Chairman is hereby authorized to execute any documentation associated with the foregoing and this loan.
- G. Committee received an update on the status of the Russell County IDA/Lebanon Inn loans.
- H. Upon motion by Rick Axthelm and duly seconded by Larry Mosley, and unanimously passed with all members present voting in favor thereof, none voting against the same, none abstaining, and with Josh Ball and Carroll Branham absent, the board approved a request from the Economic Development Authority of Scott County ("EDA") to extend the loan closing deadline on the up to \$300,000.00 loan approved on October 19, 2017 to the EDA to assist with the development of a new industrial site at the Riverside development, to a new loan closing deadline of April 18, 2019.

Chairman called for old business, and Rick Axthelm invited other board members to attend the next time the Project Review Committee interviews seed capital applicants.

Chairman called for new business, and there was none.

Upon motion by Harry Childress and duly seconded by Carroll Branham, and unanimously passed with all members present voting in favor thereof, none voting against the same, none abstaining, and with Vince Barnett absent, the board approved up to a \$433,000.00 grant from the VCEDA Civil Penalties Fund to the Breaks Interstate Park Commission to be used to develop infrastructure and improvements at the Breaks Interstate Park, specifically the additional clearing of right of way for the electrical infrastructure to serve the park, site preparation and hydroseeding, the transfer of utility lines to new poles and the removal of old poles, the replacement of the roof on a park building, the improvement and/or replacement of the septic system for the Adventure Outpost, structural support improvements for the Laurel Lake cabins, replacement and/or repainting of rusted stairwells, the purchase of catering equipment, the construction of the Potter's Flats pedestrian bridge, and costs associated with the foregoing including architectural, engineering, delivery, and installation expenses. The VCEDA Chairman is hereby authorized to execute any documentation associated with the foregoing and this grant.

- G. Upon motion by Harry Childress and duly seconded by Jim Baldwin, and passed with all members present voting in favor thereof, except Josh Ball and Duane Miller voting against the same, none abstaining, and with Vince Barnett absent, the board approved a request from Project Jonah to extend the loan closing deadline on the up to \$10,000,000.00 loan conditionally approved by VCEDA on August 17, 2017 for this project, to a new loan closing deadline of December 31, 2020, with all other terms and conditions to remain the same. The VCEDA Chairman is hereby authorized to execute any documentation associated with the foregoing.
- H. Upon motion by Harry Childress and duly seconded by Maggie Asbury, and passed with all members present voting in favor thereof, none voting against the same, with J. P. Richardson and Frank Underwood abstaining, and with Vince Barnett absent, the board approved up to a \$5,610,000.00 loan to the Industrial Development Authority of Buchanan County ("IDA") to be used to finance building(s) construction, build-out, and improvements, site development, site grading, parking lot construction, road construction, paving, concrete pad(s) and apron(s), utilities installation, exterior lighting, the purchase of equipment, machinery, and tools, other improvements, and costs associated with the foregoing including architectural, engineering, inspection, permit, legal, delivery, and installation expenses, for an expansion of Paul's Fan Company to the Southern Gap industrial shell building and approximately 14.5194 acre site ("the Facilities") located in the Southern Gap industrial park in Buchanan County, Virginia, subject to the following terms and conditions:
  - 1. The loan shall be due and payable in one hundred eighty (180) consecutive monthly payments of principal and interest, with the first such monthly payment due and payable twelve (12) months from the date of the promissory note (the "Note"). The initial one hundred seventy-nine (179) such monthly payments shall be due and payable at the rate of \$15,670.39 per month. The 180th and final monthly payment shall be a balloon payment equal to the remaining unpaid principal and interest balance of the Note. If at least thirty (30) full-time jobs have been averaged at the Facilities during Years 2-6 from the date of the Note, and fifty (50) full-time jobs have been averaged at the Facilities during Years 7-11 from the date of the Note, and sixty (60) full-time jobs have been averaged at the Facilities during Years 12-16 from the date of the Note, then (provided that all payments due on the Note have been paid and the Note is not in default) the 180th monthly payment (as described above) shall be forgiven and converted into a grant. However, if the foregoing employment milestones have not been achieved, then the 180th monthly payment shall be a sum equal to the remaining unpaid principal and interest balance of the Note multiplied by a fraction, the numerator of which shall be the

number of full-time jobs averaged at the Facilities during Years 2-16 from the date of the Note, and the denominator of which shall be eighty (80).

- 2. The interest rate shall be 0%. Provided, however, that if at least forty (40) full-time jobs have not been averaged at the Facilities during Years 2-6 from the date of the Note, then on the sixth annual anniversary date of the Note, the interest rate shall increase to 2.25%.
- 3. The loan shall be collateralized by a deed of trust on the Facilities, and by a first priority security interest in any equipment, machinery, and tools financed with these VCEDA loan proceeds. Said deed of trust may be subordinate to any existing deed(s) of trust on the Facilities securing VCEDA.
- 4. This loan shall be funded from the VCEDA Buchanan County Account.
- 5. The lease-purchase to Paul's Fan Company and/or its affiliate(s) (including Paul's Repair Shop, Inc. (d/b/a Paul's Fans)) of the real estate, equipment, machinery, and tools securing this VCEDA loan, is hereby approved. Such lease-purchase shall be on terms and conditions acceptable to the VCEDA Executive Director/General Counsel.
- 6. No loan closing fee shall be required on this loan.
- 7. The maturity date of the \$2,080,000.00 promissory note dated September 3, 2015 from the IDA to VCEDA (concerning a loan to originally construct the Southern Gap shell building) (the "Shell Building Note") is hereby extended to the same final maturity date as the Note. On this final maturity date, the outstanding principal and interest balance of the Shell Building Note shall be due and payable on the same basis as the final 180th payment on the Note. In other words, if the 180th payment on the Note is forgiven as provided above, then the outstanding principal and interest balance of the Shell Building Note also shall be forgiven and converted into a grant (and the Shell Building Note marked "Paid" and the Credit Line Deed of Trust dated September 3, 2015 from the IDA securing the Shell Building Note shall be released). If the 180th payment on the Note does not qualify for full forgiveness as provided above, then the outstanding principal and interest balance of the Shell Building Note shall be due and payable at the same time as the 180th payment on the Note and based upon the same

percentage as the 180th payment described above (i.e., the amount due and payable on the Shell Building Note shall be a sum equal the outstanding principal and interest balance of the Shell Building Note multiplied by a fraction, the numerator of which shall be the number of full-time jobs averaged at the Facilities during Years 2-16 from the date of the Note, and the denominator of which shall be eighty (80)).

- 8. On each annual anniversary date of the Note (but not later than 30 days following such), VCEDA shall be provided with a written employment report documenting the number of full-time jobs at the Facilities on the most recent annual anniversary date of the Note, along with the average wage rate of said full-time jobs.
- 9. The VCEDA Chairman is hereby authorized to execute any documentation associated with the foregoing and this loan.
- I. Upon motion by Harry Childress and duly seconded by Larry Mosley, and unanimously passed with all members present voting in favor thereof, none voting against the same, none abstaining, and with Vince Barnett absent, the board approved up to a \$1,025,000.00 loan to Paul's Fan Company to be used to finance the purchase of real estate, building(s) construction, build-out, and improvements, site development, site grading, parking lot construction, paving, access road construction, utilities installation, the purchase of equipment, machinery, and tools, other improvements, and costs associated with the foregoing including architectural, engineering, permit, legal, delivery, and installation expenses, for an expansion of Paul's Fan Company to the Constitutional Oaks industrial shell building and approximately 16.844 acre site (the "Facilities") located in the Constitutional Oaks industrial park in Lee County, Virginia, subject to the following terms and conditions:
  - 1. The loan shall be due and payable in one hundred twenty (120) consecutive monthly payments of principal and interest, with the first such monthly payment due and payable twelve (12) months from the date of the promissory note (the "Note"). The initial one hundred nineteen (119) such monthly payments shall be due and payable at the rate of \$4,411.76 per month. The 120th and final monthly payment shall be a balloon payment equal to the remaining unpaid principal and interest balance of the Note. If at least five (5) full-time jobs have been averaged at the Facilities during Years 2-6 from the date of the Note, and at least ten (10) full-time jobs have been averaged at the Facilities during Years 7-11 from the date of the Note, then (provided that all payments due on the Note have been paid and the Note is not in default) the 120th monthly payment (as described above) shall be forgiven and

converted into a grant. However, if the foregoing employment milestones have not been achieved, then the 120th monthly payment shall be a sum equal to the remaining unpaid principal and interest balance of the Note multiplied by a fraction, the numerator of which shall be the number of full-time jobs averaged at the Facilities during Years 2-11 from the date of the Note, and the denominator of which shall be fifteen (15).

- 2. The interest rate shall be 0%. Provided, however, that if at least five (5) full-time jobs have not been averaged at the Facilities during Years 2-6 from the date of the Note, then on the sixth annual anniversary date of the Note, the interest rate shall increase to 2.25%.
- 3. The loan shall be collateralized by a first lien deed of trust on the Facilities, and by a first priority security interest in any equipment, machinery, and tools financed with these VCEDA loan proceeds.
- 4. The initial up to \$500,000.00 of this loan shall be funded from the VCEDA Lee County Account, and the remaining up to \$525,000.00 of this loan shall be funded from the VCEDA Coalfield Revolving Loan Fund. Payments received on the loan shall be applied first to the amount borrowed from the VCEDA Coalfield Revolving Loan Fund.
- 5. No loan closing fee or Phase I environmental assessment shall be required on this loan, and an attorney's real estate title opinion shall be provided in lieu of title insurance on this loan.
- 6. Upon the closing of this loan, VCEDA shall receive \$100,000.00 from the sale by the Economic Development Authority of Lee County (formerly known as the Industrial Development Authority of Lee County) ("IDA") to Paul's Fan Company and/or its affiliate(s) (including Paul's Repair Shop, Inc. d/b/a Paul's Fans) of the Constitutional Oaks Shell Building, which \$100,000.00 shall be applied to the outstanding balance of the \$200,000.00 Promissory Note dated December 17, 2008 owed by the IDA to VCEDA (the "Shell Building Note") concerning the original construction of the shell building. Upon VCEDA's receipt of said \$100,000.00, the remaining principal and interest balance of the Shell Building Note shall be forgiven and converted into a grant, the Shell Building Note shall be marked "Paid", and the Credit Line Deed of Trust dated December 17, 2008 from the IDA to secure the Shell Building Note shall be released.

- 7. On each annual anniversary date of the Note (but not later than 30 days following such), VCEDA shall be provided with a written employment report documenting the number of full-time jobs at the Facilities on the most recent annual anniversary date of the Note, along with the average wage rate of said full-time jobs.
- 8. The VCEDA Chairman is hereby authorized to execute any documentation associated with the foregoing and this loan.
- J. Committee received an update on the Scott County EDA/Mountain Top Timber Products loan.
- K. Upon motion by Harry Childress and duly seconded by Carroll Branham, and unanimously passed with all members present voting in favor thereof, none voting against the same, none abstaining, and with Vince Barnett absent, the board approved up to a \$2,154,240.00 grant to the Industrial Development Authority of Buchanan County, Virginia ("IDA") to be used to finance site grading, site development, road construction, paving, parking lot construction, storm drainage improvements, utilities installations and extensions, fiber optic installations and extensions, other improvements, and costs associated with the foregoing including architectural, engineering, inspection, and permitting expenses, for the development of a paved access road from State Route 744 to the Southern Gap industrial shell building and connecting to the Greenbrier Road extension, the development of two additional project-ready graded sites adjacent to said access road, the extension of utilities along said access road, paving around the industrial shell building and construction of an adjacent parking lot, and extensions of fiber optic broadband in the Southern Gap industrial park and development area in Buchanan County, Virginia. This grant shall be funded from the VCEDA Buchanan County Account. The VCEDA Chairman is hereby authorized to execute any documentation associated with the foregoing and this grant.

Chairman called for old business, and there was none.

Chairman called for new business, and there was none.
