On April 14, 1972, [Redacted]

[Redacted] made available a postcard addressed to ALY SCHWIMMER, President, Israel Aircraft Industries, Lod, Israel, which is enclosed hereto. The card is signed by [Redacted] and has a return address of [Redacted]

A color drawing appears over the postmark, which includes a replica of the American flag and an undistinguishable caricature. The card, dated March 3, 1972, is as follows:

"Do you know the conspirators who have used my name in an international plot to defraud, terrorize and massacre while attempting to hide the facts in the assassination of an American President?"

[Redacted] stated that a second card with the identical message, same return address, and same drawing over the postmark was received by [Redacted] Israel Aircraft Industries, Lod. [Redacted] displayed the card addressed to [Redacted]. The two cards were given to [Redacted] by the Israeli Ministry of Defense Security Officer on March 24, 1972. He does not know when the cards were received but presumes sometime during the late part of March, 1972. [Redacted] according to [Redacted] have no record of [Redacted]

[Redacted] is hopeful of obtaining any pertinent, significant data with regard to [Redacted] and/or the person residing at the above Miami address.

Tel Aviv indices contain no record of [Redacted]
