(iii) Encryte of Melli-purpose Organizations. Such expenditures do not receive any more way way we way and a solution of the contributions. The percentage of the general fund which is used for such expenditures indicates the percentage of does, assessments, or other contributions which may be considered to have been paid for that purpose. Therefore, in reporting receipts, such arganizations may specify what that percentage is, and report their dues, assessments, and other contributions on that basis. However, each contributor of \$500 or more is to be listed, regardless of whether the contribution was made solely for legislative purposes.

(c) IF THIS REPORT IS FOR AN AGENT OR EMPLOYEE.--(i) is General. In the case of many employees, all receipts will come under Items "D 5" (received for services) and "D 12" (expense money and reimbursements). In the absence of a clear statement to the contrary, it will be presumed that your employer is to reimburse you for all expenditures which you make in connection with legislative interests.
