FOR THE GOD WHO STRETCHED OUT THIS PLANET AND ESTABLISHED THE NATIONS UPON THE EARTH, TO EACH HIS HERITAGE AND COUNTRY, HE ALONE DISPERSED ISRAEL IN THE FOUR WINDS, YET NEVER OBLIGED THEM TO ABANDON THEIR LAW AND THEIR OBLIGATION TO THEIR PEOPLE AND FELLOW COUNTRYMEN.
