Is is edinithed that the inerio or cruaisation Ie an sfriliste of the Tornt Etontat Congroet. is an affizinte of the Morld Mioniet Congrose the Orginisation is aubjeet to the proviulions of the Conatitation of the Iorla Zlantat Oangress. Artiole 79 of tho Congreset Oonekifution indiostos that an element of eontrol esista Inimeuph es politiecl negotiations udth governsents the the Langue of Motions may be ounituetad by 2 2onint groxpe conly Nith the approvel of the Breeutive Cungreses. The artilele furthar ntitas thit the nelhesion of boilos to the 8 tioniet preaniantion promuppoes that in a11 21 cnist guentlans the duty of disolglins fa rogard to tho Zionist Organisntion (aproroatily mennting the Congrian) mut talse procedance over the daty of dilelpline In regard to iny othur argenisrtion. 13 eolplinsyy Bonsuras dighlapt matbor froupe are provided in the artiele.

To sumarise, the llorld 2 inatat Congrese divecta the pollotos of the Aaorionn Zioniet ergenisation as one of 4 ts afrilintes and hy ite Constitation exaretsep moes: fegrae of control ovar eertein of the

Organipation's aelivitios. The World Congreas appanys to oome dithin the definttion of "foreign prinoipal" inuaniach as 10 is an "aseociation . . . organisation . . . having its prinoipal plaos of businoss in, a foreign country." It would meen, thersfore, that the fierican zionlet Organisation is one owio within the Untted Staten molicite . . . moner for a fordign prinofpai" and Anhu within the Ninited States acts at the oxder, raquent or under the atreotion of a foresgn prineipal at least in some of Its activitiess ${ }^{\text {a }}$ Legally, therafore, I beliove this is a case for applieation of the Not. The zioniat Organisation of Aneriea has consiatently dented 1iah1iity to reghater under the let, first in itis lether of Sejptenber 9, 1938, aist ill a soaferende reported in a mpmoranduin dated Auguat 20, 1941 and agoin in a 2etter dated Oetober 8, 1942. Wie have no masaon to expeet that there thowla be any change now in the Organiantion's position as to regietration. Angthar ietter mould probably result in s repeated refusel to reglater. Throat of proseoution or actual probecution by the Departaient of Juatice for fallure to register suens to be the only ramatning affective action. Bat I doubt that suoh aotion would be narranted under the efreunstances at thls theite.
